INTRODUCTION

The information in this booklet is intended to be used as a guide towards further research of the veteran. Given is, in the following order:

Name of veteran; or widow (districts key), Post Office; "Remarks and Disabilities;"
Rank and Company, Unit; Dates of Service.

There are a few Confederate Soldiers included.

Due to illegible writing, information in the "Remarks and Disabilities" columns was often unclear, and for that reason is quoted.

The information under "Dates of Service" in many cases did not agree with the "Length of Service."

The "districts key" refers to information from the top of the census page: first number is Enumeration District; second number is Supervisor's District; third number is Minor Civil Division. Occasionally some were combined; thus the (11,12,13-1-34).

There are a few veterans included whose Post Office is given as Anderson County, Tennessee.
